CORPORATE RISK LEADERSHIP AWARD <i>This award will recognize a distinguished individuals who have made significant, lasting contributions to the risk management field over the course of their careers (15+ years).</i>	
Participation Criteria : Senior risk management professionals with a proven track record of over 15 years in the field. <i>Note: We allow self-nomination or nomination by a team member</i>	Weighting
1.Ability to demonstrate leadership in managing risks and influencing industry policies, with a focus on successful strategies and crisis management	30%
2. Ability to showcase effective risk management frameworks, standards,methodologies or educational programs in Malaysia, aligned with the best practices and international standards	30%
3. Evidence of technology adoption in providing innovative risk mitigations tools e.g. Artificial Intelligence (AI) as part of risk management strategies to address key challenges	25%
4. Ability to demonstrate lasting impact, mentorship, and contribution to future risk leaders	15%
NEXT-GEN RISK PROFESSIONAL AWARD <i>This award acknowledges an exceptional young professional under the age of 35 who have introduced innovative, creative, and technology-driven solutions to improve risk management practices.</i>	
Participation Criteria: Professionals under 35 years of age who have demonstrated innovative approaches to risk management. <i>Note: We allow self-nomination or nomination by a team member</i>	Weighting
1.Evidence of innovative approaches and solutions in identifying, navigating, and mitigating risks, demonstrating a creative and forward-thinking mindset	30%
2. Showcase the ability to foster collaboration and teamwork within the risk team and organisation-wide, ensuring a collective effort in managing risks	30%
3. Demonstrate successful contribution to the organisation, including specific projects	25%
4. Ability to demonstrate proactive identification and mitigation of emerging risks	15%

CATEGORIES OF 2026 AWARD - ORGANISATIONS AND INSTITUTIONS

CATEGORY & DETAILS	
RISK CULTURE EXCELLENCE AWARD <i>This award recognizes organisations that have successfully embedded a strong risk-aware culture across all levels of their operations.</i>	
Participation Criteria : Open to all organizations with dedicated risk management function	Weighting
1.Ability to demonstrate effective communication of risk-related information, fostering a strong risk culture across all levels	30%
2. Ability to showcase how risk management is embedded across departments through structured processes and practices	30%
3. Evidence of risk management initiatives that helped to instill risk culture and contribute to continuous improvement	25%
4. Evidence of leadership’s active role in promoting and prioritizing risk management within the organization.	15%

CYBER RISK DEFENSE EXCELLENCE AWARD <i>This award honors organisations with exceptional cybersecurity risk management practices that effectively mitigate cyber threats.</i>	
Participation Criteria: Open to all organisations and learning institutions	Weighting
1.Ability to demonstrate successful deployment of security measures to prevent and mitigate cyber threats	40%
2. Ability to showcase programs designed to educate employees and stakeholders on cyber threats, best practices, and resilience strategies	35%
3. Ability to demonstrate the adoption of AI, automation, encryption, and other cutting-edge solutions to strengthen cybersecurity defenses	15%
4. Ability to showcase alignment with national and international cybersecurity regulations (e.g., ISO 27001, NIST, PDPA) to maintain industry best practices	10%

Timeline for Initiatives:

The structure, activities, initiatives, and projects involved must have taken place between January 2025 until May 2026.

Award Ceremony Announcement:

The announcement of winners and the unveiling of the top submissions will take place at the MARIM Conference.

ABOUT THE JUDGING PROCESS

Judges:

Judges are experienced practitioners currently holding senior positions in Risk Management or are senior educationists in the field.

Possible Clarifications:

The judging panel may seek further clarification or request a presentation from the entrant if needed.

Confidentiality of Best Submissions:

The top 3 submissions for each category will remain confidential until the award ceremony at the MARIM Conference.

Judges' Discretion:

The judging panel reserves the right not to issue a shortlist or make an award if entries do not meet the required standard. The decision of the judging panel is final, and no correspondence will be entertained.

Confidential Judging Process:

The judging process is confidential and relies solely on the material submitted by participants.

Use of Information:

Information received will not be share to any third party, except JUDGES of this award only. Information received will not be used for commercial and non-commercial purposes.
